Registration

Altamonte Springs Recreation will hold an on-site registration on Saturday, May 21 from 9:00a.m. until 1:00p.m. at Westmonte Park. Participants will also have the option to register online beginning April 4.

Fees

The non-refundable fee is \$335 per teenager (cash, check, money order, Visa and Mastercard are accepted). Families with two teenagers will be discounted at \$315 per child and families with 3 or more teenagers will be discounted at \$295 per child.

Starting May 2, city residents of Altamonte Springs will have the option to pay \$50 per teenager per week and non-residents will have the option to pay \$60 per teenager per week.

NOTE: Space is not guaranteed for the entire summer. This option is for families whose teenager will only be attending a portion of the nine-week summer camp. All weekly payments must be made at least one week in advance.

Lunch

Participants will be required to bring lunch from home. For those who participate in the weekly field trips, lunch will be governed according to the rules of that particular attraction.

Swimming

Swimming will be offered throughout the course of the program on a weekly basis. Participants will be transported to Westmonte Park Center or Lake Brantley Athletic Complex Pool for swim lessons.

Field Trips

During the course of the program we have numerous career oriented field trips planned, which will be no charge for the participant. On Thursdays, we have optional field trips, these trips are scheduled to area attractions for an additional cost. In order to take part in these trips, participants must have a wavier and release from liability signed by a parent/guardian.
